Ken Allred has been active in the International Federation of Surveyors (FIG) since attending his first congress in Stockholm in 1977. He has served as the Canadian delegate on Commission 1 -Professional Practice since 1981. In Melbourne in 1994 he was elected chair of Commission 1 for the term 1994 - 1998.
