In the following three years posted to Survey and Mapping Office and in charge of a District Survey Section responsible for cadastral and topographical surveys. Had also undertaken aerial survey work.

In 1979, promoted to Senior Land Surveyor in charge of Hong Kong Island Survey District responsible for the cadastral and topographical surveys.

In 1983, in charge of the computerization in the Survey and Mapping Office and the special task of implementing a Computerised Land Information System. Extensive study and investigation in the field of GIS was carried out including overseas site visits and attending conferences.

In 1988, promoted to Chief Land Surveyor and put in charge of a multi-million dollar Land Information System Project in the Survey and Mapping Office, Lands Department.
